Open Call for Entries

We invite Eastern Oregon artists to participate in a **river theme** art show. *Ripples in Time* is a celebration of the Middle Fork of the John Day River, its rich history and the efforts underway to assure it remains wild and free. Artists are invited to explore and recreate their own reflections of the various aspects of river life. Join us in celebrating rivers and art.

About the Event: *Ripples in Time - Middle Fork John Day River Celebration* is a one day event to be held on Saturday, June 9, 2012 at the new Bates State Park. The event will explore the history of the river and people's interactions with it through time. Demonstrations, displays, restoration tours, food, music, art and fun are all part of the celebration sponsored by the North Fork John Day Watershed Council.

About the Art Show: A **river theme** art show, in conjunction with *Ripples in Time*, will be held at the Austin House Cafe' and Country Store, Austin Junction at the intersection of Hwy 26 & Hwy 7. **Exhibition dates are June 9 through June 17, 2012.**

Entries: Submissions may include painting, drawing or photography. Works should be appropriately presented, matted and/or framed and ready to hang with hardware and wire attached. Up to two pieces will be considered. ***Space is limited. Dimensions not to exceed 24" x 20" including frame.** Artists may choose to offer their work for sale. There are **no entry fees.**

*Please note - if entries exceed available space, selections will be based on artistry and theme representation. Every effort will be made to include all works. Artists whose work is not selected will be contacted and must retrieve work Thursday, June 7, 1 - 4 p.m., or Friday, June 8, 11 a.m. - 4 p.m. Neither the sponsor nor the Austin House Cafe' and Country Store takes responsibility for any items not collected.

Delivery: **Artwork must be hand-delivered** to the Austin House Cafe' and Country Store, Austin Junction Hwy 26 & 7, Bates, Oregon, on **Wednesday, June 6, 2012 between 12 noon and 4 p.m.** No shipped or mailed artworks will be accepted.

Pick Up: **All artwork must be picked up on Monday, June 18, 2012, between 12 noon to 4 p.m.** No works may be shipped or stored.

Liability: Every reasonable precaution will be taken in handling entries. However, neither the sponsors, nor the Austin House Cafe' and Country Store, will assume responsibility for any loss or damage to artwork or frames. The entering of a work of art shall be understood to imply agreement with all conditions set forth in this entry.

Instructions: Fill out an entry card (black font) and attach to the back of each work. Fill out a public display card (brown font) for each piece and deliver with your work.
